Location

India Mill Centre, with its 303 ft. high chimney, is an imposing landmark building in Darwen town centre. The building is situated in an established commercial area convenient for shops and public transport facilities and within close proximity to Manchester city centre. Neighbouring occupiers include ICI and a Sainsbury's supermarket.

Junction 4 of the M65 motorway lies only 2 miles to the North and offers access to the major road network via the M6 motorway. There is also ample car parking on site as well as good public transport links.





India Mill Centre


India Mill is a remarkable Grade II Listed building constructed between 1859 and 1871, including the erection of the 303 ft high Italian campanile chimney, which still dominates the skyline of Darwen and is a Grade II* Listed structure in itself. India Mill has undergone major transformation over recent years to become an established Business Centre within the Darwen community.

Over 800 people enjoy working at the India Mill Centre which houses a cross-section of businesses ranging from large national customer service operations to small regional creative and professional services.

Retaining some of its original features, the accommodation presents character offices within a professional business environment that meets the needs of modern businesses.


